## Model Release

This agreement between Kris Saelen, Pieter Heuvelmansstraat 25, 2300 Turnhout (B) (hereafter "the Photographer") and \_\_\_\_\_\_ (hereafter "the Model") concerns a photo shoot of following nature: Portrait, (Latex & Fetish) Fashion/ Glamour, Swimwear, Lingerie, Topless, (Artistic) Nudes, Bodypaint\* (\* delete as appropriate)

The photo shoot is done on voluntary basis. The Model and the Photographer agree that they do not own any mutual compensation, financial or other for the photo shoot.

The Model will receive a selected number (max. 5) retouched photos from the shoot. The selection will be made in mutual agreement between the Model and the Photographer. The Photographer will transfer digital versions of the photos to the Model. The photos will have sufficient resolution to produce prints of max 20cm x 30cm

The Photographer owns the full copyrights to the photos. The Model will will own the image rights.

Both parties can only use the photos for personal, non-commercial use. The photos can only be published to promote the work of either party—trough a personal website, (printed) portfolio or (online) publication—and will credit the Model and the Photographer. Any and all publication should never harm the good name of either party. Publication by any party other than previously agreed, is only allowed after mutual written consent. A new agreement or contract may need to be negotiated at that point which may include financial or other compensation.

Additional to the general terms and conditions stipulated in this agreement, both parties agree to the additional terms:

Both parties will adhere to below general terms and conditions:

Art. 1.a: the Model confirms he/she is of legal age the day of the photo shoot and that he/she meets conditions to make this agreement legally binding.

Art. 1.b: if the model is not of legal age the day of the photo shoot, the Model's parents or legal guardian(s) will have to agree to the photo shoot and sign the agreement prior to the start of the photo shoot. The Model will have to be accompanied by his/her parents, a legal guardian or a person of confidence the day of the shoot.

Art. 2: the use of intoxicating substances or narcotics prior or during the photo shoot is not permitted. The Photographer has the right to cancel the photo shoot at all times if the Model in under the influence of intoxicating substances or narcotics without any right to compensation on the part of the model.

Art. 3.a: the use of the photos for activities related to matchmaking (i.e. dating sites or dating agencies) is not allowed.

Art. 3.b: publication on social media (including but not limited to Facebook, Twitter, Instagram & Snapchat) is only allowed on the party's personal profile and with prior written approval of all parties.

Art. 3.c: publication for purposes not allowed by local law, including but not limited to publication in pornographic publications, inciting or glorifying racial hatred and incitement to the use of or glorifying drugs is strictly prohibited.

Art.. 4: the Model or a party working for the Model is not allowed to retouch the photos at any time.

Art. 5: the Photographer has the right to retouch the photos or to use them in compositions without prior consent of the Model. All image manipulations should be intended towards improving the photo and should never harm the good name of the Model.

Art. 6: the Photographer has the right to enter the photos in competitions and art expositions without prior consent of the Model.

Art. 7: infringement or breach of agreement give both the photographer and the model the right to seek compensation in accordance with the provisions and rules under Belgian law.

Art. 8: in case of circumstances beyond the control of the Photographer like but not limited to dataloss due to theft, damaged equipement or loss of equipment or data ("act of God") the Model has not right to compensation, financial or other. A new date for a new photo shoot will be agreed between the Photographer and the Model.

Art. 9: the Photographer can not be held accountable for misuse of the photos by a third party.
